The legacy was created in 1855 by two brothers and their cousin who jointly operated a milling and manufacturing company in the Midwest. Hard work, ingenuity and the growth of industry built a thriving company with capital for expansion, and in 1900, the Laird and Norton families partnered with Frederick Weyerhaeuser to acquire and manage timberlands in the Pacific Northwest and create the Weyerhaeuser Company.

Through the middle of the 20th century, the Laird and Norton families founded many companies in the forest product industry, such as Potlatch Lumber and Company, Boise Payette Lumber Company and General Timber Company. This success along with an infusion of capital from the Initial Public Offering (IPO) of Weyerhaeuser in 1963 resulted in the need for trust administration and asset management services, which prompted the founding of Laird Norton Trust Company in 1967.
